CALL TO ORDER

The meeting of the Hebron Town Council was called to order at 7:02 p.m. by President Rick Dwyer, with Commissioners Ronald Ayers and Amelia Handy in attendance. David Hooper and Chester Sebald were absent.

MINUTES

The minutes of July 17, 2019 meeting were presented. Commissioner Ayers made a motion to approve the minutes as presented. The motion was seconded by Commissioner Handy. The motion was passed unanimously.

OLD BUSINESS

- 1) Rauch Inc. presented the report findings associated with the Maryland Department of the Environment funded Stormwater Management study. They summarized the tasks to identify existing conditions and drainage problems and to make prioritized recommendations. Two areas of concern were Walnut and Lillian Street infrastructure. The plans will be available for review and comments by citizens until 8/30/19.
- 2) Commissioner Dwyer reported that Mr. John Verrill had submitted two additional complaints about parties at 300 S. Main. Mr. Dwyer added that Mr. Hall had been contacted directly about the matter. Ms. Bellamy added that Mr. Verrill reported 8/19/19 that there had not been any parties the previous weekend.

NEW BUSINESS

- 1) Commissioner Dwyer stated the Wicomico Goes Purple campaign was in full swing and showed the wrist bands, ribbons, yard signs, etc. which were part of opioid awareness.

OTHER

- 1) Commissioner Dwyer introduced Ms. Lisa Ludwig to present on the Lower Eastern Shore Heritage Area collaboration with Scenic Byways, progress and opportunities. She left several pieces of information.
- 2) A citizen, Kristin Roberts spoke to the code enforcement issue pertaining to untagged vehicles at her 502 S Main residence. After much discussion, the Commissioners voted to allow her until 10/1/19 to tag or move the camper. The motion was made by Commissioner Handy and seconded by Commissioner Ayres. All were in favor and the town manager was instructed to send formal notification of the action.
